

Mitcham Industries Declares Cash Dividend on its 9.00% Series A Cumulative Preferred Stock

("Mitcham" or the "Company") (Nasdaq: MIND) announced today that it has declared a quarterly cash dividend on its 9.00% Series A Cumulative Preferred Stock ("Series A Preferred Stock") for the first quarter of its fiscal year ending January 31, 2019.

In accordance with the terms of the 9.00% Series A Preferred Stock of the Company, the Board of Directors has declared a Series A Preferred Stock cash dividend of \$0.5625 per share for the quarterly period that began on February 1, 2018, and ends on April 30, 2018. The dividend on the Series A Preferred Stock is payable on April 30, 2018 to holders of record at the close of business on April 15, 2018. The Series A Preferred Stock is currently listed on the Nasdaq and trades under the ticker symbol "MINDP".
